#### About this book



This book is written by the Victorian Law Reform Commission or VLRC.

VLRC check that laws are fair in Victoria.



We want your help to make it easier for victims of sexual assault to get help.



Victims are people who had a crime happen to them.

Sexual assault is sexual activity that a person does **not** want.



For example

• kissing you do **not** want



• touching you do **not** want



• sex you do **not** want.



#### Why did we make this book?

People who are sexually assaulted find it

- hard to speak up or get help
- hard to get justice.



Justice means the person who did the crime must face what they did. For example, the person might

- go to court
- meet with the victim in a safe place with someone to support them.



The Victorian Government asked us to think of ways to make it easier for victims to get help.



We made this book to ask you some questions and get your ideas.

# Who can give us ideas?

We want to hear from adults from Victoria who

• were sexually assaulted

or



 know someone who was sexually assaulted.



You can give us ideas even

• if you did **not** tell the police about the assault



• if you did **not** go to court.

We will listen to all ideas seriously.



We want ideas from people

- with disability
- in aged care





- in prison
- in different parts of Australia
- of different genders and sexualities. For example, gay people.



We will also listen to people who are Aboriginal or have a **CALD** background.



#### CALD means

- you speak a different language
- you or your parents were born outside Australia.

# How will we use your ideas?





We will

- get ideas from lots of people
- write a report



• give the report to the government.



The government will use our report to help victims of sexual assault in the future.



The government might

• change laws



• change support programs



• keep good programs going.

You do not need to tell us

• about the assault

If you are an adult we will **not** tell anyone your name or contact information.



We might have to tell the police if you are under 16.

This is a law that keeps children safe.



The law says we must tell the police if

• the police do **not** know about the assault





you were 16 or younger on
27 October 2014.

#### Other ways to deal with sexual assault



There are other ways for victims to get better after sexual assault.



Victims can get help to talk to the person who hurt them to tell them how much they were hurt.
